#### Benjamin Ostrofsky, Ph.D. 177<sup>th</sup> Class

Dr. Benjamin Ostrofsky, an engineer and Fellow of the Society of Logistic Engineers, has the distinction of being the only person in the organization's history to receive its top three awards. In addition to his Professorship in Industrial Engineering at the University of Houston, Dr. Ostrofsky has served as a consultant to many governmental bodies and commercial enterprises, including The Johnson Space Center/NASA, The United States Department of Energy, and Coca Cola. He is a member of numerous professional associations and academic honor societies, and the recipient of several awards and honors, including having his name engraved on the *National Aviation and Space Exploration Wall of Honor* at the Smithsonian Institution.

#### Bernard M. Wagner, M.D. 182<sup>nd</sup> Class

Dr. Bernard Wagner is a world-renowned scientist and leading pioneer in the field of Toxicologic Pathology. Dr. Wagner's over 50 years in medicine have included consulting with the Department of Defense, Department of State, and Armed Forces Institute. Dr. Wagner has the exceptional distinction as the first American scientist under the Kennedy-Khrushchev agreements sent to Moscow to exchange manned space data in 1962. Additionally he has served as the Director of Pathology at several hospitals throughout the country. His professional associations include the Royal College of Pathologists (London) and the National Academy of Sciences. He has served as the President of International Academy of Pathology, receiving that organization's Distinguished Service Award.

#### Richard J. Fox 184<sup>th</sup> Class

Richard J. Fox, Founder and Chairman of The Fox Companies, has been at the helm of major real estate development in Pennsylvania and New Jersey since 1952, with both The Wachovia Center and Comcast television studios among his crowning achievements. Mr. Fox also serves as Chairman of Planalytics, Inc., a strategic marketing and sales management company. His lengthy record of service to the community includes 36 years as a Trustee of Temple University, including 16 years as Chairman, Chair of the Jewish Policy Center, board member of The Federation of Jewish Agencies of Philadelphia, and former President of the Pennsylvania Home Builders Association.

#### Robert A. Fox 188th Class

Robert A. Fox, Chairman and Chief Executive Officer of R.A.F. Industries Inc., a private investment firm, has had an accomplished career in the world of business. He has served as the Chairman and Chief Executive Officer of both the Warner Company and Waste Resources Corporation. He is a leader in community service, serving on the boards of four financial institutions, the Foreign Policy Research Institute, the Wistar Institute, Gesu School, and as a Trustee of the University of Pennsylvania.

#### A. Eugene Kohn, FAIA RIBA JIA 190th Class

A. Eugene Kohn, architect, is Founder and Chairman of Kohn Pedersen Fox, a firm of architects and planners voted among the Top Five Most Admired Firms. Mr. Kohn has been the Principal-in-Charge of six projects that have won the National AIA Design Award. Two of his award winning projects include the World Bank Headquarters in Washington, D.C. and the DG Bank Headquarters in Frankfurt, Germany. Mr. Kohn's extensive accomplishments include national and international lectures on contemporary architecture from Kuala Lumpur to London. He is a former Trustee for the University of Pennsylvania and currently a member of the Board of Overseers at the University of Pennsylvania's Graduate School of Fine Arts and Wharton Real Estate Center Advisory Board.

#### Howard Gittis, Esq. 197th Class

Howard Gittis is an accomplished attorney with professional achievements in both the fields of law and business. He is the Director, Vice Chairman and Chief Administrative Officer of MacAndrews & Forbes Holdings Inc. and has served as a Director on a number of corporate boards, including Revlon Inc. and Sunbeam Corporation. Dr. Goldberg established the ultrasound division at Thomas Jefferson University Hospital and became Director of the Jefferson Ultrasound Research and Education Institute (JUREI) in 1992. JUREI has been recognized by the World Health Organization as its only Collaborating Center for Continuing and General Education in Diagnostic Ultrasound. He has held academic appointments including but not limited to positions at Temple University Health Sciences Center, Drexel University, and Hahnemann Medical College. He has held the position of President in several Ultrasound Societies. Dr. Goldberg has received numerous honorary professorships, memberships, and fellowships from around the globe.

#### Stephen J. Harmelin, Esq. 206<sup>th</sup> Class

Stephen J. Harmelin, an exceptional attorney with over 35 years of experience in corporate law, has been listed numerous times in **The Best Lawyers in America**.
